President Harmon read the Land Acknowledgement:

- Jewish Student Union Director Gabay: The Jewish Student Union Advisory Council has selected the next Assistant Director; will email the Secretary of Appointments on Friday to get them on the forwarding letter. At 6pm next Wednesday, hosting an event with the Hispanic Latinx Student Union.

- Hunter, Office of Governmental Affairs: Please read the legislative agenda and provide your comments and amendments. Supports enhanced training for sexual violence prevention, opposing limiting efforts in House Bill 57, textbook affordability, equitable education, accessibility and safety on campus.

Caroline Ball for Student Council for Accessibility Advocacy Assistant Director, Alberto Garcia Marrero for Supreme Court Associate Justice

Hunter: **POI**, where are the Judiciary minutes?

Randall: **POC**, the Vice Chair was not at the meeting and is still catching up on taking minutes from the recording.

- Opening Statements:

- Ball: Apologizes for background noise; at philanthropy event. Currently the Assistant Director, and there is no Director, so I am acting Director and been doing the heavy lifting for this new bureau. Did the financial budget report, planning events, and contacting other RSOs to elaborate. Recruiting for the organization. Financially certified.
- Marrero: Went to Florida International University for undergraduate degree and currently a second-year law student at FSU. Interned at the 11th Judicial Circuit and the Southern District of Florida. Served on the Elections Commission last year as Vice Chair and acting Chair during the transition of Supervisor of Elections. Familiar with Elections Code, Statutes, and Constitution.

- General Questions:

- Wang: For Candidate Marrero, What is the most significant challenge facing the Supreme Court and how can it be addressed?
 - Marrero: Accessibility to the court is an issue, as students do not know we have a court or what it can do. I will work on accessibility and transparency.
- Hunter: For Candidate Marrero, how do you plan to interpret Statutes?
 - Marrero: I am a textualist; plain language determines plain meaning. If there is ambiguity, then there can be a discussion.
- Hunter: For Candidate Ball, what projects do you have in mind that you believe you can accomplish as Director, now that you have served as Assistant Director?
 - Ball: Since this is a new bureau and I am mostly focused on getting the word out, budgeted for 2 social events to reach out to the community. Believe that the best way to advocate for people is to get to know people and listen. Reaching out to RSOs and bridging the gaps between the various organizations in this community. Need to reach out before planning change.
- Wang: For Candidate Marrero, how will you handle parties being disrespectful to each other?
 - Marrero: Parties should only be speaking to the court, not to each other. The Chief should step in, but any Justice can. Remind them that they are not their to fight out their issues and only to help the court find resolve.
- Gonzalez: For Candidate Ball, what is your budget for the 2021-2022 year?
 - Ball: Just under \$3,000.
- Gonzalez: **POI**, the Student Council for Accessibility Advocacy was not budgeted for this year.
- Marcus: For Candidate Marrero, aside from the Elections Commission, do you have any ties to SGA at FSU?
 - Marrero: No.
- Marcus: For Candidate Marrero, What did you mean in your application regarding the election of Homecoming Council? We do not elect them.
 - Marrero: That is my mistake, I was under that impression from my undergraduate institution. Still emphasize the importance of fair elections and justice in the violations process.
- Linsky, with reservation for a follow-up: For Candidate Ball, what is charity you are at right now?
 - Ball: Milkshakes for Miracles with the Childrens' Miracle Network.
- Linsky: For Candidate Ball, can you show us the event with the camera?

- Ball: Shows the event.
- Wang: For Candidate Marrero, How will you interpret Statutes when you disagree with the text?
 - Marrero: My interpretation will be based on the text, even if I disagree with the outcome.
- Gonzalez, with reservation for 3 follow-ups: For Candidate Marrero, have you ever held a position or played a role in a campus political campaign?
 - Marrero: No.
- Gonzalez: For Candidate Marrero, the American Bar Association's commentary to its judicial conduct says that it is inappropriate for a judge to hold membership in any organization that discriminates on the basis of race, sex, or religion. Can you please list all organizations you belong to, or have belonged to since graduating high school?
 - Marrero: In undergraduate school, was a member of Phi Alpha Delta Pre-Law Fraternity, Pre-Law Association for Honors, 2 leadership honor societies, Golden Key Honor Society. Now, on Florida's state Bar Association, Cuban American Bar Association, Federal Bar Association, Federalist Association, and Business Law Society.
- Gonzalez: For Candidate Marrero, Has anyone involved in the process of selecting you as a judicial nominee discussed with you any specific case, legal issue, or question in a manner that could be interpreted as seeking assurances concerning your position?
 - Marrero: No.
- Gonzalez: For Candidate Marrero, what are your views on the role of judiciary in our government and the criticism involving judicial activism.
 - Marrero: Judiciary's role is to maintain the balance of power and interpret legislation without getting involved in political questions and does not take cases that will cause issues in society. It is not the job of the court to create law, and it all goes back to the text.
- Randall: for Candidate Marrero, can you define judicial activism?
 - Marrero: The ideology that attempts to interpret intent in the writing of legislation rather than upholding clear language, and changing the law through their interpretation.
- Marcus: For Candidate Marrero, If a case were to be brought involving someone you had a relationship with, how would you handle that?
 - Marrero: There needs to be an argument that there is a true conflict, and then I would remove myself.
- Preshia: For Candidate Marrero, what is the Federalist Society?
 - Marrero: An organization that advocates for open discourse and discussion from both sides.
- DuChene: For Candidate Marrero, justices who claim to be textualists are criticized for it. Can you describe how you would use textualism consistently and how you would fill the holes that textualism sometimes cannot answer?
 - Marrero: Yes, some judges and justices who claim they are textualists deviate from that. I am truly a textualist in that I look at the text first. The gaps do not exist for those who are true textualists because gaps will be filled by the legislature.
- T. Murray, with reservation for a follow-up: For Candidate Ball, how many people except yourself are currently on your board?
 - Ball: None, it is just me. Doing some recruiting and believe some people are in the application process right now. This is a new bureau so outreach is crucial.
- Hunter, with reservation for 2 follow-ups: For Candidate Marrero, what feedback have you received that you think will be important for your role?
 - Marrero: I do not have an answer to that.
- Hunter: For Candidate Marrero, How long do you think it will take you to start making meaningful contributions to the court once in this position?

- Marrero: Not long at all, familiar with the court and worked with justices in the past.
 - Hunter: For candidate Marrero, how do you see the judicial branch aligning with the legislative branch in the future?
 - Marrero: Because of separation of powers, communication and advising when needed.
 - Wang: For Candidate Marrero, Do you believe it is appropriate to issue your opinion on legislation that is going through the committee process in Senate?
 - Marrero: No.
 - Gonzalez: For Candidate Marrero, textualism has been referred to as something that lacks ability to discover and adequately dispose of discriminatory laws drafted with sophisticated language to hide discriminatory intent. How would you counter this argument?
 - Marrero: Academia is very different from practice. Such critique of textualism puts burden on the court to fulfill a role that is not the responsibility of the court. It is the responsibility of the legislature to change the law.
 - Linsky: For Candidate Marrero, can you recall a recent case at FSU you would have dissented on and why?
 - Marrero: From the last session, I would have dissented on one elections case in which the standard was muddled and motions were dismissed that should not have been upheld. For the merits of the case itself, there was not convincing evidence in front of the Elections Commission but such evidence appeared in front of the Supreme Court.
 - Gonzalez: For Candidate Marrero, are you saying that even if a law has discriminatory repercussions, it is not the job of the court of counter those?
 - Marrero: There is a difference between the law being seen as discriminatory, and being holistically unconstitutional. If the law is unconstitutional, is it the court's job to reverse it. It is not our job to change the meaning of constitutional laws.
 - Hunter, with reservation for a follow-up: For Candidate Marrero, on your application you said your leadership style is calculated, can you elaborate on that?
 - Marrero: Appreciate teams because it encourages learning the strengths and weaknesses of each other. Do not believe that leadership is just directing people and delegating, you have to understand your team.
 - Hunter: For Candidate Marrero, you also mentioned in your application your goal to make judiciary open to all. As someone who had to testify in front of the court at 9pm, it does not seem that the court is focused on accessibility in that regard, so what changes do you plan to make to court operations?
 - Marrero: Agree that the late meetings make it difficult. Making it more known to students that they can attend these hearings in the first place is crucial. Not sure why the times have been set at night, but can look into it.
 - Marcus: **POC**, that case was scheduled that way due to class conflicts.
 - Gonzalez: For Candidate Marrero, seeing that this Senate often relies on legislative intent, can you explain how legislative intent falls under how you interpret Statutes?
 - Marrero: Very rarely do I rely on legislative intent, because new Senators are coming in often and intent does not serve well when intent changes. We cannot assume. The only time I have looked at intent and history is when Statutes change due to a disagreement with the opinion of the court.
- **Marcus moves to forward the candidates individually, Randall seconds; no objections**
- Closing Statements:
 - Ball: Since this bureau is new this year, everything starts somewhere. You need to spend time with people in the community before advocating for them to hear their story and help them in the ways they want.
 - Marrero: As a follow-up to one of the questions is that I could do better in being less direct. Look forward to serving in this role and maintaining separation of powers.

 - Tackett: Added that position name changes still count as major offices. Proviso language means that this will not go into effect until the next board.
 - Gonzalez: Solidifies the stature of the Office of Governmental Affairs in SGA and get them back to where they used to be. They used to lobby at local, state, and federal level.
- Technical Non-Debatable Questions:
 - Hunter: Is there precedent for proviso language?
 - Tackett: Yes.
- Pro:
 - **Randall moves to amend, Nasworthy seconds**
 - **Linsky objects**
 - Opening Statement:
 - Randall: In the current form, I do not agree with the top 4 positions automatically being considered major offices. It is really difficult to define these positions broadly because different organizations have different names. However, the definition applies as long as the criteria of the position fits.
 - Technical Non-Debatable Questions:
 - Linsky: When did you speak with both primary sponsors?

- Technical Non-Debatable Questions:
 - Hunter: Can you define members-at-large?
 - Linsky: They are defined in Statutes in the Organic Act for the Office of Governmental Affairs. There are 9 at-large members who are not in the other positions that make up the board.
 - Gonzalez: Are you aware that by including the Director of the Office of Governmental Affairs you will be repeating it, because it already says directors of bureaus?
 - Linsky: Doing the same thing with Presidents of the Unions. Friendly to amendments. The whole point is to not kick the Student Body President, Senate President, and Speaker of COGS off of OGA.
 - Randall: Would you be open to an amendment that says the members of the OGA Board of Directors as listed in 908.2A excluding elected positions?
 - Linsky: Willing to make that compromise.
 - Pro:
 - **Randall moves to amend, Tackett seconds; no objections**
 - **Sponsor finds it friendly; amendment is adopted**
 - Marcus: **POI**, are both 10 and 11 meant to be struck?
 - Harmon: No, formatting issue.
 - Con:
 - No speakers
 - **T. Murray moves to call the question, Nasworthy seconds; no objections**
 - Closing Statement:
 - Linsky: If this is somehow construed in the future to say elected for 4 different offices within smaller areas of the community such as an agency office, that is not the legislative intent.
 - Vote: 24-4-0
 - **RESULT: AMENDMENT IS ADOPTED**
 - Hunter: **POI** for the sponsor, would the OGA Deputy Director be considered the Director of a bureau?
 - Tackett: Yes.
 - Linsky: In support with the proviso language. Would not need the proviso in a perfect world, but would be unfair to the current OGA board because we did not do this before confirming their board. We are about to enter a special session and then the full session shortly after. Would do a disservice to the FSU community if we remove the proviso and make the Director start from scratch with the appointments of the board.
 - Marcus: Given that we have already confirmed the OGA Board, the proviso language makes perfect sense.

- Tackett: This does more than just deal with OGA. Discovered in Judiciary committee that our Webmaster Ben Young is in a major officer position. Removed that because we saw it as unnecessary.

Minutes needs its own position because we need detailed minutes; everything needs to be recorded and this results in minutes being 30-35 pages long. As former Clerk, my minutes were about 20 pages and it would take me several days after Senate to get everything done. Our current Clerk tracks every piece of legislation by emailing committee chairs, running the Canvas, putting together the Calendar. Minutes requires typing constantly for the whole meeting, then rewatching the recording for anything missed. When one leadership position does not show up, it is really difficult to transition it to someone else, as we saw with the Parliamentarian having to take minutes and not being able to help Senators during that time. A Clerk would be able to track legislation during Senate and answer questions Senators may have about legislation. We know how much our current Clerk works, and she came up with this idea. This makes a healthier Senate for the future.
- Technical Non-Debatable Questions:
 - Tackett: If passed, do you feel the Historian will need pay for their work?
 - Roy: No opinion until that comes through.
- Pro:
 - Marcus: This originated after a conversation I had with the Clerk in the parking lot after a Senate meeting when she was very close to resigning. She is very stressed and stretched thin. This is a position that was vacant for so long and we are so gracious she filled the role. It is a hard role and it is exacerbated by the spotlight on Senate in the current climate. I did not write the legislation but advised that Roy do it, and he has done a great job.
 - Hunter: **POI**, given that this would take effect once signed, would the current Clerk choose which position they would like to fill?
 - Roy: Proviso language specifies this will start at the Sine Dine of this Senate.
 - Randall: **POI**, do you think this is wise given the current Clerk position is not often filled?
 - Roy: Yes, we have seen Clerk positions filled. In my 2 years in Senate, we only had 3-4 months without a Clerk. My role as Clerk was what Historian is under this. Currently we have a full board, and had 2 applications for Clerk when the current Clerk was forward.
 - Marcus: **POC**, the position is undesirable in its current state and is not likely to be filled in its current state.
 - Randall: **POI**, do you think there needs to be a full time person dedicated to tracking legislation as opposed to delegating that role to someone else?

- Harmon: Yes, I hope.
 - Randall: Did you reach out to Student Publications?
 - Jacalyn: Student Publications does not do professional headshots.
 - Marcus: Is the name of the photographer Westcott Photography?
 - Harmon: Yes.
- Pro:
 - Randall: Gives students the opportunity to get headshots for LinkedIn or other reasons. Asked Senate and the Executive Branch to advertise this so all students know about this.
 - Marcus: **POI**, are these headshots available to all?
 - Harmon: Yes.
- Con:
 - No speakers
- **Hunter moves to pass by acclamation, Nasworthy seconds; no objections**
- **RESULT: BILL 67 PASSES BY ACCLIMATION**
