 - Brayden H: Spoke to faculty and faculty member said that they wouldn't be affected

 - Jason: There is more to the bill than just DEI

- Brayden H: We should make good decisions when it comes to representing people, "make the right decision"
- Zorrian: Have agencies spoken out?
- Alexis: Yes
- Melanie: Agencies are taking steps against this
- Jason: "I don't know if that's the majority of students"
- Zorrian: Agencies are hosting events
- Lauren: What will FSU's SGA saying something about this do?
- Zorrian: SGA is going to do what they're going to do
- Brayden H: The university will not make a statement, there's an issue with polling an agencies because it's only capturing a small group of people on the same side, there's misinformation, will be voting against because equity is important and we need to represent the student-body not just a minority
