 - Vice-Chair Turkomer inquired about the RSO's membership as well as requirements for entry

 - Motion to fund \$800 in the category of contractual services by Vice-Chair Turkomer, seconded by Senator Bettley.
 - Motion to fund \$175 in the category of food by Vice-Chair Turkomer, seconded by Senator Bettley.
 - Motion to fund \$1386 in the category of food by Vice-Chair Turkomer, seconded by Senator Bettley.
