Committee Business:

● **Chabad at FSU:**

○ **Preliminary Questions:**

- Asking for: \$3150 in the category of contractual services
- Date Request Submitted: January 13th, 2022
- Date of Event: February 24th (Might be moved to March 1st)
- Number of Active Members: 85 members
- Number expected to come: 100-150 people
- Fundraised: \$0

○ **Notes of the Event/Item:**

- The RSO is requesting funding to bring a guest speaker to their temple. The RSO mentioned that they will advertise their event through flyers here on campus.
- Member Rowan inquired about whether the RSO had reached out to other organizations to increase attendance.
- The RSO mentioned they had reached out to multiple organizations on campus however some organizations did not want to be affiliated with the event.
- Member Rowan inquired about how the organization plans on dealing with any protest.

- Vice-Chair Turkomer inquired about the date of the event as well as the amount fundraised.
- Member Rowan mentioned concerns regarding the lack of advertising as well as collaboration with other organizations here on campus.
- Vice-Chair Turkomer raised concerns regarding the cost of the quest speaker.
- Member Sai mentioned that tabling the RSO might be in the organization and the committee's best interest.
- The committee decided that tabling the RSO would provide the RSO with ample amount of time to address the concerns of the committee.
- Motion to table RSO by Vice-Chair Turkomer, seconded by Member-at-Large Rowan

- **White Mouse Productions:**

- **Preliminary Questions:**

- Asking for: \$805 in the category of expenses
- Date Request Submitted: January 20th, 2022
- Date of Event: March 25-27th (Show Dates)
- Number of Active Members: 16 members
- Number expected to come: 25-40 people
- Fundraised: \$200-250

- **Notes of the Event/Item:**

- The RSO is requesting funding to fund for their Spring production equipment.
- The RSO mentioned that they need funding to purchase equipment for shows as well as a podcast that they are launching.
- Vice-Chair Turkomer inquired about the date of the event, amount fundraised as well as the number of active members.
- Member Rowan inquired about whether the RSO would be able to cover the sales tax.
- Chair Roy inquired about vendor eligibility for specific items the RSO has requested.
- Vice-Chair Turkomer mentioned his full support for the proposal.
- Member Rowan mentioned his support for fully funding the proposal and suggested funding amazon as the vendor for each item.
- The committee decided that it would be best to fund the RSO using Amazon as the vendor for each item since they are an approved vendor, and the cost difference was insignificant.
- Motion to fund \$805 in the category of expenses by Member Rowan, Seconded by Vice-Chair Turkomer.

- Asking for: \$438 in the category of Expenses, \$88 in the category of Food, \$300 Clothing and Awards.
- Date Request Submitted: January 21st, 2022

- Date of Event: February 28, 2022
- Number of Active Members: 45 members
- Number expected to come: 100 people
- Fundraised: \$0
- **Notes of the Event/Item:**
 - Member Rowan inquired about why the organization was asking for increased funding for the bench.
 - Member Rowan inquired about the color cost associated with the bench.
 - The RSO representative mentioned that the color cost is necessary as it allows the bench to blend in with the FSU environment.
 - Member Rowan inquired about the location of the benches.
 - Vice-Chair Turkomer inquired about membership as well as amount fundraised.
 - During deliberations Member Rowan inquired about if the plaques would be considered an award.
 - Member Rowan mentioned that he is in support of funding for expenses and food, however he mentioned that he would like to half fund the plaques.
 - Vice-Chair Turkomer mentioned his support for fully funding the clothing and awards category.
 - The committee decided that it would be best to fully fund the clothing and awards category with the stipulation that the finance committee would deliberate the subject of the funding allocated for clothing and awards.
 - Motion to fund \$438 in the category of Expenses by Vice-Chair Turkomer, Seconded by Member Rowan
 - Motion to fund \$88 in the category of Food by member Rowan, Second by Vice-Chair Turkomer
 - Motion to fund \$300 in the category of Clothing and Awards by Vice-Chair Turkomer, seconded by member Rowan.

- **Korean American Student Association:**

- **Preliminary Questions:**
 - Asking for: \$33 in the category of expenses, \$138 in the category of food
 - Date Request Submitted: January 20th, 2022
 - Date of Event: February 26th at 12 p.m.
 - Number of Active Members: 120 members
 - Number expected to come: 40 people
 - Fundraised: \$375
- **Notes of the Event/Item:**
 - The organization is requesting funding for hosting a “Running Man” event.
 - Vice-Chair Turkomer inquired about the membership, fundraising and expected attendance.
 - Member Rowan inquired where the fundraising amount was allocated.
 - Chair Roy inquired about how the RSO has been doing recently and asked questions to better understand the inner workings of the organization.
