○ **Notes of the Event/Item:**

- For the speaker there were three options, but Kenny was the cheapest at \$100 and his quotes were through text messages.
- The organization is preparing a contractual service agreement to send to him very soon.

- These events will be advertised through social media and through collaboration with other universities like CHAW, but the committee has encouraged them to find even more sources to advertise with.
- Member-at-Large Rowan verified the permits regarding the handling of food have been procured.
- The organization does not have an itemized list of quotes for the grilling day event so the committee has recommended tabling the organization to allow the representative to come back with that information.
