- **Disc Golf at Florida State University:**
  - **Preliminary Questions:**
    - Asking for: \$659 in the category of clothing and awards.
    - Date Request Submitted: November 24, 2021
    - Date of Event: Tabling on Landis every Wednesday.
    - Number of Active Members: 30 members.
    - Number expected to come: 50 people.
    - Fundraised: \$0
  - **Notes of the Event/Item:**
    - Disc Golf is requesting funding in order to purchase t-shirts for their organization. They will be recognized as an intermural sports club after being an RSO for one year. The Rez hosts disc golf tournaments occasionally.
    - Senator Diaz asked Chair Roy if the request was up to the standards outlined in the financial manual.
    - Vice-Chair Turkomer asked about the number of active members in the organization, as well as expected attendance and fundraising.
    - Member Rowan voiced his support for the resolution citing the simple process of the request.

- Vice-Chair Turkomer also voiced his support for the resolution, citing that although the requested number of shirts is higher than the number of current members,
- Motion to fund \$659 in the category of clothing and awards by member Rowan, seconded by Vice-Chair Turkomer.

- Asking for: \$1625 in the category of food.
- Date Request Submitted: February 23<sup>rd</sup>, 2022
- Date of Event: April 2<sup>nd</sup>, 2022.
- Number of Active Members: 125 members.
- Number expected to come: 200-250 people.
- Fundraised: \$4222.21.

- **Notes of the Event/Item:**

- The organization is requesting funding in order to purchase Filipino food to serve during the Barrio Fiesta.
- The event will be held at the Wesley Foundation.
- The event will be advertised via flyers and social media.
- The RSO mentioned that their nole central membership number was outdated, and that their actual membership count is higher than that.

- The RSO is requesting funding in order to fund purchase t-shirts to showcase the existence of the organization and create a sense of community.
- Vice-Chair Turkomer asked about expected attendance, active members, as well as amount fundraised.
- Member Rowan inquired how much the organization had been funded prior.
- Member Rowan mentioned his support for the proposal citing low cost and high expected attendance.
- Vice-Chair Turkomer asked the RSO if they could cover the cost of the tax burden, they said they would be able to.
- Vice-Chair Turkomer mentioned his support for the request citing the acquired benefits as well as the expected interest in the shirts.

- Motion to fund \$951 in the category of clothing and awards by member Rowan, seconded by Vice-Chair Turkomer.
