 - **Huynh:** How much are you all charging to use the dunk tank?
 - **Representative:** Last year it was a dollar per throw or maybe it was two dollars per throw, then we had some bundles, and people could donate money.

We have Turkish symbols on the shirts such as the Evil Eye, and the shirts also have the SGA logo. These t-shirts will increase our membership by advertising our organization. This will make our campus more inclusive.

 - **Chair Humberg:** Do you have a picture of the design?
 - **Representative:** Yes, I can show you.
 - **Chair Humberg:** How will these shirts be distributed?
 - We will not be selling them; we will be giving them to members.
 - **Damion Huynh:** How was the turnout for your last event?
 - **Representative:** We had about 10 because it was during the week, but we usually have about 20-25.
 - **Damion Huynh:** How many members do you have that were also members last year? How many new members do you have?
 - **Representative:** Probably about 10 new members. Now, that I am thinking about it, we probably only need 15 shirts per size as opposed to 30 with our membership.
 - **Chair Humberg:** Ok, so I'll half the amount.
 - **Staveski:** Will these shirts be available to nonmembers?
 - **Representative:** Yes; however, mostly members come to our meetings.
 - **Staveski:** How are your meetings advertised?
 - **Representative:** On our social media

Roundtable Discussion:

- **Parker Bevis:** I am open to funding them the full amount, especially after cutting the price in half.
- **Damion Huynh:** I am also willing to go with the half amount because I do not think they need the full 120 t-shirts.
- **Staveski:** I do not know if I love the idea of us funding 60 shirts because they are using the same shirts as last year and only have 10 new members with only 10 coming to their last GBM. Their returning members should already have the shirts. How do we feel about cutting them down to 30 shirts?
- **Huynh:** I agree.

Our noncompetitive teams and general body require no application. We are hoping to hold events such as this one to expand our membership. Without the help of SGA, we will not be able to provide food at this event.

 - **Chair Humberg:** How many active members do you have in the organization?
 - **Representative:** Our competitive team has 40 people, and our noncompetitive team has 21 members. Our general body has 25 to 30 more dues-paying members.
 - **Parker Bevis:** Are two members of your organization financially certified?
 - **Representative:** Yes
 - **Humberg:** Are any of these vendors approved?
 - **Representative:** Yes, two of them.
 - **Staveski:** I see on your application that you all fundraised \$7000 last year was that mostly from dues, or did you have other fundraising efforts last year?
 - **Representative:** Last year was the first year that we did other efforts, and we made around \$300.

 - Fundraised: \$1100 (last year) and \$6,000 from Sweepings
- **Opening:**
 - Our purpose is to empower, encourage, and assist minority women who are pursuing careers in law. Black women make up less than two percent of people in the legal field. We want to empower women to take this leap. We offer law school support, panels, and merchandise. First, we are requesting funds for merchandise. We believe that this will empower our members and community. In the past, we have only offered shirts to our members, but now we would like to offer these shirts to everyone on campus. In previous years our t-shirt quotes have been between 700 and 900. We want to increase our presence on campus through

merchandise. We have gotten funding from SGA in recent years. SGA has partial funded us for t-shirts in the past. These would be given out on Landis, involvement fairs, and at Market Wednesday. We are requesting \$280 for a website to foster transparency and expand our reach. We are also requesting for a table banner to attract more members. The least expensive quotes come from first press. The event that we wish to put on is an induction ceremony and banquet. We want to invite prominent lawyers and people from the Tallahassee Community. This event will be open to the public. The event is November 30th. We are requesting \$850 for food, \$105 for a photographer, and \$550 for cords, pins, and certificates. We are planning to use a student photographer. We host several events such as informationals and GBMs. We would like to request funds for snacks to create a welcoming environment for people to socialize and increase attendance at events. \$20 for each event with 12-15 events in total and 16 Market Wednesdays at a cost of \$15 each.

- **Questioning:**

- **Humberg:** How did you determine that there will be 60 people at this event?
 - **Representative:** We have approximately 40 members in our organization, and we are in our application process so we do not have a concrete number as to how many that will be, but based on the form that should be about 15. Then, we will be inviting 6-10 attorneys depending on who responds. We plan to promote the event through social media.
- **Staveski: Is your photographer an approved vendor?**
 - **Representative:** I would have to check.
- **Humberg:** I would recommend you all use the Student Publications Photographer as they do not charge, and they have high-quality equipment. Would you all be okay with this?
 - **Representative:** We did not know that FSU offered this. I will reach out to them for sure.
- **Bevis:** Are at least two members of your board financially certified?
 - **Representative:** Yes
- **Humberg:** How many t shirts did you all get funding for before?
 - **Representative:** We purchased 100, but SGA only funded 50.
- **Staveski:** Have you all done any fundraising, outside of dues?
 - **Representative:** We have tried to do a share-it-night in the past, but I do not think we had enough members to get any money from it.
- **Bevis:** How many active members do you have in your organization?
 - **Representative:** We have 13 on our e-board, 20 active members, and 15 applications. We have 40 people in our GroupMe.

- **Roundtable Discussion:**

- **Chair Humberg:** So, we decided to fund Sonny's BBQ for their banquet for \$850.62. Not fund the photographer as they can use the free one through Student Publications, fund them for certificate paper and buttons from Staples (\$6.04 for a 25 pack of certificate paper and \$0.97 per button), and encourage them to use Student Publications. We cut the quantities of wristbands from 400 to 100,

stickers from 300 to 50, and the quantity of t-shirts from 100 to 75. This cut the clothing and awards category from \$1,950 to \$954.63. This brings the total down to \$2,125.23 from \$3,400.
