Bills First Reading:

- Bill 92 Sponsored by Senator Brewer (P) Arellano, Birdsong, E. Brown, Dennig, Gummerman, McEntyre, Mendez, Newsome, Sparling, Syska, Waterio (Co)
This Bill would convert the Catholic Student Union ("CSU") from a Registered Student Organization to an Agency. This would make CSU the eighth esteemed identity-based Agency at FSU. **(Referred to Student Life, Judiciary, Internal Affairs, and Finance 10.18. Tabled in Student Life 10.20. Passed in Judiciary 10.20. Failed in Internal Affairs 10.24.)**
- Bill 93 Sponsored by Senator Widmann (P) Baez, Gorelick, Hellman, Humberg, Patel (Co)
An allocation of \$955,661 from Sweepings to various departments and organizations. **(Referred to Sweepings 10.18.)**
- Bill 94 Sponsored by Senators White and Randall (P) Widmann, Diaz (Co)
Exempting budgeted entities from the requirement of acknowledging SGA

funding on printed and audio/video materials.

Bill 95 Sponsored by Senators Seeger and Staveski (P) Arellano, Hellman, Randall, Sparling, Widmann (Co)
This bill creates a Budget Commission with a committee makeup similar to that of Sweepings, allowing both Senators in other committees such as PAC and RTAC to help with budget allocation as well as individuals from the Executive Branch. This bill also gives the other duties of the Budget Committee to the Finance Committee. Upon passage, this bill would take effect in the 76th Student Senate.

Requiring future Senate Presidents to appoint Senate liaisons to the Union Board and Campus Recreation Boards.

Bill 90 Sponsored by Senator Salazar (P)
Budget reallocation within the HLSU budget to accommodate for misallocations when first dividing up the budget. Allocating \$1750 from HLSU contract to HLSU food and expenses in the form of \$1250 to HLSU food and \$500 to HLSU expenses. **(Referred to Budget 10.18. Passed in Budget 10.23.)**

Bill 91 Sponsored by Senator White (P)
To change PAC and RTAC membership statues to expand participation on the funding boards. **(Referred to Judiciary and Finance 10.18. Passed in Judiciary 10.20. Passed in Finance 10.24.)**
