Bills First Reading:

Bill 93 Sponsored by Senator Widmann (P) Baez, Gorelick, Hellman, Humberg, Patel (Co)
An allocation of \$955,661 from Sweepings to various departments and organizations. **(Referred to Sweepings 10.18. Sweepings hearings are ongoing.)**

Bill 94 Sponsored by Senators White and Randall (P) Widmann, Diaz (Co)
Allowing budgeted SGA entities the ability to have their entity's logo featured in printed materials instead of the SGA logo. **(Referred to Judiciary and Finance 10.25. Passed in Judiciary 10.27. Pending in Finance.)**

Bill 95 Sponsored by Senators Seeger and Staveski (P) Arellano, Hellman, Randall, Sparling, Widmann (Co)
This bill creates a Budget Commission with a committee makeup similar to that of Sweepings, allowing both Senators in other committees such as PAC and RTAC to help with budget allocation as well as individuals from the Executive Branch. This bill also gives the other duties of the Budget Committee to the Finance Committee. Upon passage, this bill would take

effect in the 76th Student Senate. **(Referred to Judiciary, Budget, Finance, and Rules 10.25. Passed in Judiciary 10.27. Failed in Budget 10.30)**

- Bill 96 Sponsored by Senator White (P)
A bill to remove the Student Broadcast Center from Statues.
- Bill 97 Sponsored by Senator LoBianco (P) Randall, White (Co)
A transfer of \$1000 from Senate Projects to the Food for Thought Pantry to assist FSU by earning the university points for the Beat UF Food Drive.
- Bill 98 Sponsored by Senator White (P) Gorelick, Gummerman, Hellman (Co)
To reform Senate Project statutes to allow the funding to utilized in a
more
effective manner that can make a greater impact on the student body.
- Bill 99 Sponsored by Senator White (P)
To Align the Campus Recreation Board Statues with other SGA entities to make sure those interested have the opportunity if a vacancy occurs.
- Bill 100 Sponsored by Senator Windlan (P) Barresi, Burton, Garcia, Gorelick, Hine, McEnery, Randall, Staveski (Co)
This bill modifies the election code to establish an opportunity for every candidate running for an SGA office to have a 100-word statement about their qualifications and/or reasons for running published on the SGA website and made accessible to the student body at least 48 hours prior to Student Government Association election day.

To better promote transparency from the Student Senate and to attempt to reach more members of the student body.

Requiring that the Union Board and Campus Recreation Boards post their committee members, meeting minutes, annual budgets, and relevant bylaws on the Union and Campus Recreation websites to ensure greater transparency with the student body.
- Bill 103 Sponsor by Senators Lento and Velazquez (P) Anandjiwala, Diaz, Staveski, Widmann (Co)
This bill proposes a new process for Student Government apportionments in order to best represent the Student Body population.
- Bill 104 Sponsored by Senator Diaz (P) M. Brown, Humberg, Meier, Randall, Sparling (Co)
Transfer within the Senate Branch account to subsidize the cost of Senate t-shirts.
- Bill 105 Sponsored by Senators Diaz, Randall (P) M. Brown (Co)
Senate Projects transfer for the Childcare Center to fund new playground

equipment for children. This will hopefully become part of an annual tradition known as the Senate Presidents' Project.
