I. GENERAL

- A. No account funded by A&S fees may pay any stipend, wage, or salary increase to any positions not funded in Sweepings 2022 without the express consent of the Student Senate.
- B. In the event of shortfalls or excesses, the Vice President of Student Affairs, the SGA Advisor, the Student Senate President, and the Student Body President shall meet to review options.
- C. All purchase requests shall be received prior to May 31, 2023.
- D. Any unspent funds shall be returned to the Sweepings account.

II. OPS WAGES

- A. Monies allocated to the Union in the OPS Wages Category shall be used to pay wages for student workers for the 2022-2023 fiscal year.
- B. Monies allocated to the Elections Office in the OPS Wages Category shall pay for the Deputy Supervisors of Elections for the 2022-2033 fiscal year.
- 1. The most senior Deputy Supervisor of Elections shall be paid at a rate of \$10/hour at 5 hours per week, for six weeks; \$11/hour at 10 hours per week for the 3 weeks pertaining to Elections Week; and \$11/hour at 5 hours per week for 6 weeks, totaling \$960.
- 2. The junior Deputy Supervisor of Elections shall be paid at a rate of \$10/hour at 5 hours per week, for six weeks; \$11/hour at 5 hours per week for the 9 weeks pertaining, totaling \$795.
- C. Monies allocated to the Center for Health Advocacy & Wellness in the OPS Wages Category shall be used to pay wages for a student facilitator for the Substance Use Intervention Training (SUIT) Program.
- D. Monies allocated to the RISE Office in the OPS Wages Category Shall be used to pay wages for a student assistant in the 2022-2023 fiscal year.

III. SGA OFFICES

A. Monies allocated to the Department of Student Engagement shall pay for storage lockers for Recognized Student Organizations, Lounge Furniture, Certiport software for one (1) year, two (2) Power Bars, sixteen (16) HON Pillow-Soft Bonded Leather High-Back Chairs, and window frosting for the 3rd floor of the new Student Union Building offices. Any remaining funds shall be used at the discretion of the recipient.

IV. SGA BUDGETED ORGANIZATIONS AND DEPARTMENTS

A. Monies allocated to Campus Recreation in the Expense Category shall be used to purchase sixteen (16) paddleboards, sixteen (16) kayaks, and two (2) SportsPlex Zero Turn Mowers.

V. AGENCIES

- A. Monies allocated to the Pride Student Union in the Expense Category shall be used for expenses pertaining to their planned travel to the 2023 Creating Change conference in San Francisco, CA. This conference must be open to all members of the Student Body.
- B. Monies allocated to the Womens' Student Union in the Contractual Services Category shall be used to pay for a musician to perform at FSU for Women's History Month in March 2023. \$2,500 in the Expense Category shall be reserved for start-up funds for programming pertaining to the Nineteen Ten Women's Honorary.
- C. Monies allocated to the Jewish Student Union in the Food Category shall be used to purchase food for Passover meals in Spring 2023.
- D. Monies allocated to the Asian American Student Union shall not be used to purchase office supplies.

VI. AFFILIATED PROJECTS

- A. Monies allocated to the Medical Response Unit shall be used to purchase two (2) Stop the Bleed training kits and two (2) Electric Golf Carts.
- B. Monies allocated to WVFS in the Expense Category shall be used to purchase an Orban Optimod 5700i Processor and for engineering and labor costs pertaining to a podcasting studio. Monies allocated in the Operating Capital Outlay (OCO) Category shall be used to purchase an MDL 102102 Standard Model Whisper Room.

VII. OUTSIDE DEPARTMENTS

- A. Monies allocated to the Career Center at FSU shall be used for an Iris Headshot Booth, and related shipping fees, installation fees, and three years worth of annual services.
- B. Monies allocated to the FabLab at the Innovation Hub shall be used for four (4) Prusa MK3s+3D printing machines and four (4) Prusa enclosures for said machines. Additional funds shall be used to pay for related shipments and estimated customs duty.
- C. Monies allocated to the Innovation Hub in the Food Category shall be used for the Seminole Innovators' Lunch Hour with Featured Innovators.
- D. Monies allocated to the RISE Office in the Clothing & Awards Category shall be used for the V-rak-ke-ce-tv ceremony and the Lavender Graduation.

VIII. RECOGNIZED STUDENT ORGANIZATIONS

- A. Monies allocated to the African Student Association shall not be used towards any scholarships or fellowships.
- B. Uniforms or costumes purchased with monies allocated in the Expense Category to the Attack Dance Crew shall be reusable and available to the entire team, regardless of members' ability to pay dues.

- C. Monies allocated to Hillel FSU shall be used to purchase food for Passover meals in the Spring of 2023.
- D. Monies allocated to iGem in the Expense Category shall only be used for the 2023 team competition. Monies allocated in the Clothing & Awards Category shall only be used for iGem apparel.
- E. Monies allocated to Florida PIRG Students shall not be used towards any scholarships or fellowships.
- F. Monies allocated to the Master of Public Health Student Association shall be put towards their FSU Health Conference in Spring 2023.
- G. Monies allocated to the FSU Chapter of the NAACP shall be used for contractual services, expenses, food, and clothing & awards related to their collaborative programming with Florida Agricultural & Mechanical University (FAMU) in Spring 2023. Goods bought with A&S fees must go to Florida State University students.
- H. Uniforms or costumes purchased with monies allocated in the Expense Category to the Nolettes shall be reusable and available to the entire team, regardless of members' ability to pay dues.
- I. Monies allocated to the FSU Chapter of the Tau Beta Sigma Fraternity shall be used for their Greater Music Benefit Concert.
- J. Monies allocated to TEDx FSU shall be used for the food in the reception in the 2023 TEDxFSU conference, and all food purchased with A&S monies must be available to all attendees of the conference.
- K. Monies allocated to White Mouse Productions shall be used for a 192 sq ft. Portable Stage System.
- L. Monies allocated to the World Affairs Program shall be explicitly spent on travel, lodging, gas, mileage, and registration fees pertaining to conferences and be spent in line with the provisions of the Finance Code and Student Body Statutes.

IX. SEVERABILITY CLAUSE

A. Any part, provision, or representation of this Bill which is prohibited or which is held to be void or unenforceable shall be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof.
