- Resolution 10 Sponsored by Senator Slimak (P): Amending Senate Rules of Procedure 15.3 regarding Senate Officers. **TABLED**
- Resolution 11 Sponsored by Senator Villacorta (P): Urgin the university to commit to using clean, renewable energy
 - Opening
 - Villacorta and student organizations have accumulated 3000 signatures supporting this resolution
 - The language is vague to allow the university to figure out how to do this in a way that is feasible
 - The resolution puts this on track with the university sustainability goals and the goals of the city
 - This is something that the students care about and that Senator Villacorta has spoken with facilities and sustainable campus about the feasibility of this
 - Roundtable (Motioned by Leckie, Seocnded by Murcia)
 - Motion to amend (Leckie), Murcia Seconds, Sposnor finds it friendly to add the statement "Whereas climate change is a serious threat to current and future generations at Florida State University and around the world, and"
 - Comments:
 - Daraldik: SLAA amended it not to be polarizing
 - Leckie: Believes it connects students to university
 - Baxter: Does FSU create its own power?
 - Villacorta: FSU uses about 20% of the city power grid, since Tally is moving to be sustainable by 2050 this resolution puts it in line with Tallahassee's mission
 - Baxter: Whats the intent of this resolution?
 - Villacorta: It encourages them to take certain steps to modify for Tallahassee to make that 2050 deadline, this would encourage FSU to work with the city. For that city goal to happen, all the places have to make changes. FSU has not made any public commitments to work with the city
 - Leckie: The part of the resolution that involves avoiding acting or delaying the deadline is also really important
 - Closina
